

ORDINANCE O-19-02

AN ORDINANCE AMENDING THE TOWN OF LAKE HAMILTON CODE OF ORDINANCES BY AMENDING CHAPTER 24, SOLID WASTE, ARTICLE II COLLECTION AND DISPOSAL, SEC. 24-26 TO ESTABLISH THE ALLOWANCE FOR NON-GARBAGE REFUSE REMOVAL; PROVIDING FOR CONFLICTS, SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Town of Lake Hamilton provides refuse removal services to its residents pursuant to Chapter 24 of the Code of Ordinances; and

WHEREAS, the Town of Lake Hamilton contracts its garbage removal to a franchisee and collects non-garbage refuse on its own; and

WHEREAS, the Town Council desires to set an allowance for the amount of non-garbage refuse its residents shall be entitled to have collected by the Town without additional charges.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE PEOPLE OF THE TOWN OF LAKE HAMILTON, FLORIDA:

1. That Chapter 24, Article II, Sec. 24-26, Allowance for Non-Garbage Refuse Removal, of the Code of Ordinances of the Town of Lake Hamilton, Florida is hereby added, as set forth at Exhibit "A", attached hereto and made a part hereof.

2. All ordinances in conflict herewith are hereby repealed to the extent necessary to give this ordinance full force and effect. If any portion of this Ordinance is determined to be void, unconstitutional or invalid, the remainder of this Ordinance shall remain in full force and effect. This Ordinance may be codified and made a part of the Town's Code of Ordinances

and the Sections and exhibits to this Ordinance may be renumbered or relettered to accomplish such intention.

3. This ordinance shall become effective on the date of passage by second reading.

EXHIBIT "A"

Sec. 24-26. Allowance for Non-Garbage Refuse Removal.

- (a) One (1) six-cubic-yard pickup of refuse that is not garbage, as those terms are defined in Section 24-22, per week is allowed per residence.
- (b) An accumulation of refuse that is not garbage, as those terms are defined in Section 24-22, exceeding six (6) cubic yards per week shall be considered in excess of the normal amount generated by a residence. Such excess accumulations, if placed curbside, will be removed by the Town and the resident will be charged fees set by resolution of the Town Council.

3. This Resolution shall be effective upon its adoption.
